1. Introduction

Vientiane Sarl (the "Restaurant," "we," or "us") provides this privacy policy with information on how we collect, use and disclose personal information. This Privacy Policy describes our practices in connection with information that we collect through:

- The food ordering website from which you are accessing this Privacy Policy (the "Website");

- To Oracle, the provider of the Oracle Restaurants eStore platform. We use the Oracle Restaurants eStore platform to manage order taking, our marketing campaigns, and to generate aggregated analytics information, as described above.

7. Rights and access

Your rights regarding our use and disclosure of your Personal Information.

- Whether retention is advisable in light of our legal position (such as in regard to applicable statutes of limitations, litigation or regulatory investigations).
